This name is pinned because they like to surprise. Jimmy conjured the area as a respected Agro-Social area. Including as a place for the production of plant hormones that are given the Ghost brand. Ghost stands for Superior Plant Hormone. Its products are now marketed throughout Indonesia and are in demand by many horticultural farmers.

Jimmy Hantu Foundation, in creating Pondok Tahfidz is able to carry out accountable management of education financing. It means that Pondok Tahfidz was established as an accountable Tahfidz institution with high trust for Pindok because the benefits of the Jimmy Hnatu Foundation are not only for Tahfidz institutions and their benefits but also for the surrounding community and also for the community. Guardian of the students because their children not only memorize the Qur'an but also develop their entrepreneurial spirit.
